HANDGUN RANGE RULES

1. The **Red Flag** must be displayed when this shooting range is in use.
2. **Approved Firearms for use on this range:**
 - **Handguns** in the template group .22 Long Rifle, 9mm Parabellum, .357 S & W Magnum.
 - **Rimfire Rifles**
 - **Blackpowder Firearms**The discharge of other classes of firearms is not permitted on this shooting range except for those authorized by the directors and organizers for specific club events.
Exceptions: Law Enforcement Officers may discharge .233 Remington/5.65 X45 rifles and shotguns for qualification purposes.
3. **Eye and Hearing Protection** must be worn and used by all shooters and spectators.
4. **Authorized Targets:** Paper and cardboard only
5. **Steel Targets Are Not Permitted** for use. Steel targets may be authorized for use by directors and organizers for specific club events and practice. Steel targets must not be closer than 11 metres to the shooter.
6. The use of **Golf Balls, Tin Cans, Glass, Rocks or other unauthorized items as targets** or any type of target located on the ground (range floor) **is not permitted.**
7. All targets must be attached to target stands so the line of sight is into the lower portion of the backstop berm.
8. Target placement, approved by the directors and organizers of sanctioned club events, may vary from normal target placement providing the target placement does not compromise safety.
9. **Possession or use of Incendiary or Prohibited Ammunition** is not permitted on this shooting range or on this property
10. **The Use of Holsters is not permitted.**
Exceptions: Law enforcement officers and competitive shooters where the shooting discipline requires holsters and the shooter has had the appropriate training are exempt.
11. If there are two (2) or more shooters using the shooting range, one (1) of them must be designated the **Range Officer**. The Range Officer is responsible for making all range commands, ensuring the shooting is conducted in a safe manner and has complete authority over the activities on the shooting range.
12. Firearms not in use must be unloaded and open, or safely secured in a storage container. They must not be handled while there are persons on the firing line or down range.
13. Range users must **pick up all spent cases, garbage and target materials** and dispose of the refuse in the appropriate containers.
14. Range users must put all **Portable Target Stands** back under cover when they have completed their shooting session.

Anyone violating these rules, club bylaws or other laws may have their membership revoked, without compensation, and be prohibited from entering the property
